

3rd International Mayors Summit on Living Together, December 7-8, Izmir (online)

Preliminary programme (Dec. 6)

Cities are at the forefront of social cohesion and inclusion. The COVID-19 pandemic has highlighted inequalities and the fault lines of society (i.e.: racism and various forms of discrimination, polarization and intolerance, etc.). Beyond the social tensions and inequalities exacerbated by this pandemic, cities demonstrated great leadership and creativity to provide services to the population, as well as to e, cooperation and resilience.

Building on the First Living Together Summit in Montréal (2015) and the Düsseldorf Declaration (2019), this Summit will explore the current challenges and opportunities in terms of social cohesion in cities in a context of global recovery from COVID-19.

To continue this discussion, the Izmir Metropolitan Municipality is inviting distinguished mayors, deputy mayors and thought leaders from around the world for the Third Mayors Summit on Living Together, to be held online on 7th and 8th of December, and physically on 10th December 2021 in the city of Izmir.

Our ambition is to co-create an inspiring vision of the cohesive city of tomorrow which responds to its citizens' needs. The Mayors Summit will provide unique opportunities for mayors to showcase their initiatives and meaningful conversations about strategies and solutions to current and future challenges. The event will feature online thematic workshops in a state-of-the-art-environment. The event will conclude with an on-site High-Level Panel, in Izmir, to explore the links between living together, local democracy and human rights in the city.

Cities have a responsibility to provide spaces and opportunities for exchange as well as to provide tools and conditions for developing an environment that contributes to a sense of belonging and community among residents.
